SUBJECT: HABIB-DRAPER MISSION: ISRAEL-LEBANON NEGOTIATIONS

1. (S - ENTIRE TEXT)

2. I BELIEVE WE ARE AT A POINT IN THE NEGOTIATIONS WHERE WE CAN EITHER MAKE AN EFFORT TO BRING THEM TO AN EARLY CONCLUSION OR FACE THE PROSPECT OF AN IMPASSE FOLLOWED BY PROTRACTED NEGOTIATIONS. OBVIOUSLY, I PREFER THE FIRST OPTION. I DO NOT BELIEVE IT IS IN OUR INTEREST TO ACCEPT A PROTRACTED AFFAIR WITH WHAT WOULD PROBABLY BE AN UNSATISFACTORY CONCLUSION. I SUGGEST, THEREFORE, THAT IT IS TIME WE MADE OUR OWN DECISION AS TO A REASONABLE SOLUTION TO THE REMAINING PROBLEMS. I WISH TO AVOID AN UNSATISFACTORY AND UNPRODUCTIVE COURSE BASED UPON THE FAINT HOPE THAT THE ISRAELIS AND LEBANESE WILL EACH MAKE THE NECESSARY COMPROMISES TO REACH ULTIMATE AGREEMENT WITHOUT A MAJOR PUSH FROM US.

3. THE COURSE I PROPOSE WILL DEMAND THE MOST RETREAT FROM PRESENT POSITIONS ON THE PART OF THE ISRAELIS. THIS IS NOT SURPRISING GIVEN THE EXTENT TO WHICH ISRAELI DEMANDS HAVE GONE BEYOND PURELY SECURITY CONSIDERATIONS AND THE OBVIOUS DESIRE OF THE ISRAELIS TO DOMINATE THE SOUTHERN PART OF LEBANON, INCLUDING A SUBSTANTIAL MEASURE OF DIRECT CONTROL OVER THAT REGION. THE LEBANESE MEANWHILE HAVE BEEN ANXIOUS TO ASSERT THEIR SOVEREIGNTY AND TO LIMIT THEIR CONCESSIONS TO AVOID JEOPARDIZING THEIR INTERNAL CONSENSUS OR THEIR PELATIONS WITH THE ARAB NATIONS AND ADVERSELY AFFECT THE MORALE OF THE ARMY.

4. OVER THE PAST FEW DAYS WE HAVE BEEN DISCUSSING THE UNRESOLVED ISSUES WITH THE TWO SIDES. ON THE BASIS OF THESE DISCUSSIONS, WE HAVE PRODUCED A DRAFT AGREEMENT WHICH I BELIEVE IS REASONABLE. WITH SOME EXCEPTIONS IT IS

ACCEPTABLE TO THE LEBANESE. IF WE CANNOT RESOLVE THE REMAINING ISSUES BETWEEN US, WE WILL INDICATE THE DIFFERENCES CLEARLY. AT THAT POINT, WHICH SHOULD BE REACHED ON APRIL 19, I WOULD PROPOSE TO GO TO ISRAEL AND INFORM THEM WHERE THINGS STAND. THEN, ON APRIL 20 I WOULD PROPOSE TO HAVE THE LEBANESE TABLE THE PACKAGE AGREEMENT, WHICH I WOULD SUPPORT TO THE FULLEST EXTENT POSSIBLE IN THE TRIPARTITE MEETING AT KHALDE.

5. IF ALL GOES AS I HOPE THERE WILL ONLY BE MINOR DIF-FERENCES BETWEEN US AND THE LEBANESE AT THAT POINT. ON THE OTHER HAND WE WILL PROBABLY DIFFER WITH THE ISRAELIS ON A FEW SIGNIFICANT ISSUES, AS FOLLOWS:

(A) MAJOR HADDAD. THE ISRAELIS MAY REMAIN FIXED IN THEIR DEMAND THAT HADDAD BE EITHER SECURITY ZONE COMMANDER, OR COMMANDER OF THE TERRITORIAL BRIGADE ON THE BORDER. (I PROPOSE WE SHOULD NOT AGREE, BUT RATHER SUPPORT THE LEBANESE ALTERNATIVE WHEREBY HADDAD WOULD BE DEPUTY BRIGADE COMMANDER RESPONSIBLE FOR INTELLIGENCE (G-2). THE ISRAELI DEMAND IS EXCESSIVE AND IS VIRTUALLY CERTAIN TO CREATE IN-SUPERABLE PROBLEMS FOR THE LEBANESE.) (B) UNIFIL. ISRAEL MAY CONTINUE TO OPPOSE ANY ROLE FOR UNIFIL IN THE SECURITY ZONE. THE LEBANESE WILL AGREE IF NECESSARY FOR FINAL AGREEMENT. MEANWHILE, THERE IS UNDER CONSIDERATION AN ALTERNATIVE INVOLVING A LIMITED UNIFIL DEPLOYMENT. (WE SHOULD SUPPORT LIMITED DEPLOYMENT BUT AGREE TO NO UNIFIL IF NECESSARY FOR FINAL AGREEMENT.) (C) RECOGNITION. THE ISRAELIS WANT AN EXPLICIT REFERENCE TO RECOGNITION OF ISRAEL BY LEBANON IN THE TEXT OF THE AGREEMENT. LEBANON ARGUES THAT THE AGREEMENT AND ITS CON-TENT CONSTITUTE DE FACTO RECOGNITION AND ARE NOT PREPARED TO GO FURTHER GIVEN PROBABLE ARAB OBJECTION AND THE CONSE-QUENT PROBLEMS. THEY ARGUE, MOREOVER, THAT EXPLICIT RECOGNITION SHOULD BE RESERVED FOR THE LATER PEACE TREATY. (I PROPOSE WE SUPPORT THE LEBANESE POSITION ON THE GROUNDS THAT FORMAL RECOGNITION IS BETTER RESERVED FOR LATER AGREEMENT AND WAS NOT ENVISAGED AS PART OF THE PRESENT NEGOTIATIONS.) (D) ISRAELI LIAISON OFFICERS WITH SOUTHERN BRIGADE. THE

(D) ISRAELI LIAISON OFFICERS WITH SOUTHERN BRIGADE. THE ISRAELIS WISH TO MAINTAIN LIAISON OFFICERS AT THE UNIT LEVEL IN THE TERRITORIAL BRIGADE TO BE COMMANDED BY HADDAD. THE LEBANESE REJECT ANY SUCH PRESENCE ARGUING THAT THE ISRAELI INTENTION IS TO MAINTAIN ADVISORS TO CONTROL BRIGADE OPERATIONS SIMILAR TO THE MANNER IN WHICH THEY HAVE BEEN OPERATING PREVIOUSLY. FOLLOWING IS THE TEXT OF A STATEMENT MADE BY U.S. AMBASSADOR TO LEBANON, ROBERT S. DILLON, TO CORRESPONDENTS AT 11PP HRS. (LOCAL) TUESDAY, APRIL 19.

(BEGIN TEXT)

SINCE THE EXPLOSION WHICH OCCURRED AT 1:05 P.M. YESTERDAY AFTERNOON, OUR BEST INFORMATION ON CASUALTIES IS AS FOLLOWS: THERE ARE SEVEN CONFIRMED AMERICAN DEAD, AND THERE ARE STILL EIGHT MISSING, PRESUMED PAGE 02 RUFRSGG5078 UNCLAS

DEAD. AMONG THE LEBANESE STAFF OF THE EMBASSY, WE HAVE BEEN ABLE TO ACCOUNT FOR SIX CONFIRMED DEAD AND ABOUT 40 MISSING. IT HAS BEEN DIFFICULT TO ESTABLISH AND EXACT FIGURE THUS FAR BECAUSE, ON ANY PARTICULAR DAY WE HAVE CONTRACTORS, CLEANING STAFF, ELECTRICIANS AND SO ON WORKING IN AND AROUND THE EMBASSY AND BECAUSE MANY OF OUR PEOPLE REGULARLY CONDUCT BUSINESS OUTSIDE THE EMBASSY, WE HAVE NO WAY OF KNOWING PRECISELY HOW MANY PEOPLE WERE IN THE BUILDING AT THE TIME OF THE EXPLOSION. OUR BEST ESTIMATE IS ABOUT 130, AND THIS FIGURE INCLUDES A YET UNDETERMINED NUMBER OF VISITORS AND VISA APPLICANTS.

I WILL NOT, AT THIS POINT, RELEASE THE NAMES OF PERSONS WHO WERE KILLED OR INJURED. THIS INFORMATION WILL NOT BE RELEASED BY US AUTHORITIES UNTIL NEXT OF KIN ARE NOTIFIED. THEREFORE, I THINK ITS APPROPRIATE THAT INGUIRIES OF THIS NATURE BE REFERRED TO THE STATE DEPARTMENT IN WASHINGTON, D.C.

AT THIS TIME, I WANT TO EXPRESS MY SINCERE AND PROFOUND APPRECIATION FOR THE HELP AND SUPPORT WE HAVE RECEIVED SINCE THE INCIDENT FROM OUR FIRENDS: THE LEBANESE SECURITY FORCES AND THE LEBANESE

AT THIS POINT, I WANT TO EXPRESS OUR REGRET FOR THE LOSS OF LIFE AMONG THE MEMBERS OF THE LEBANESE SECURITY FORCES WHO WERE ENGAGED IN THE PROTECTION OF THE EMBASSY. AS I THINK BACK OVER THE TERRIBLE EVENTS OF THE LAST 24 HOURS, I FEEL THAT OUR AGONY IS GREATLY MITIGATED BY THE SELFLESS, UNRESERVED SUPPORT AND HELP WE HAVE RECEIVED FROM ALL OUR FRIENDS IN LEBANON. WE HAVE BEEN SUSTAINED AND HEARTENED BY MANY EXPRESSIONS OF SUPPORT AND SYMPATHY WE HAVE RECEIVED FROM ALL OUR FRIENDS HERE.

IN CONCLUSION, I WANT TO SAY A WORD ABOUT OUR COMMITMENT TO LEBANON. THE WORK OF THIS EMBASSY WILL CONTINUE. THOSE FROM OUR VARIOUS SECTIONS WHO ARE ABLE TO WORK HAVE ALREADY BEGUN ESTABLISHING THEMSELVES IN TEMPORARY WORK SPACE, SO WE CAN RESUME OUR ESSENTIAL BUSINESS IN THIS COUNTRY. PARAMOUNT AMONG THAT ESSENTIAL BUSINESS IS OUR WORK FOR THE WITHDRAWAL OF ALL FOREIGN PAGE 04 RUFRSGG5078 UNCLAS

FORCES FROM LEBANON AND OUR SUPPORT FOR THE LEBANESE AUTHORITIES AS THEY WORK FOR FULL RESTORATION OF LEBANESE SOVEREIGNTY. FOR IT IS ONLY THROUGH THE RESTORATION OF THE ABILITY OF THE LEBANESE GOVERNMENT TO FUNCTION IN ALL PARTS OF THE COUNTRY THAT TERRIBLE TRAGEDIES LIKE THE ONE WE EXPERIENCED YESTERDAY CAN BE AVOIDED IN THE FUTURE.

EUROPEAN TROOP CONTRIBUTORS TO UNIFIL WILL MEET INFORMALLY IN THE HAGUE APRIL 20 TO DISCUSS THE FORCE'S FUTURE AND THEIR CONTINUED PARTICIPATION IN IT.

ACCORDING TO DUTCH UN MISOFF (PROTECT), THE MEETING WAS CALLED BY THE NETHERLANDS PARTLY FOR INTERNAL POLITI-CAL REASONS. HE SAID HIS GOVERNMENT MUST REPORT TO PARLIAMENT IN MAY ON WHETHER OR NOT IT INTENDS TO PARTICI-PATE IN UNIFIL AFTER THE CURRENT MANDATE EXPIRES ON JULY THE DUTCH DESIRED A "BRAINSTORMING" SESSION WITH OTHER EUROPEAN CONTRIBUTORS WHICH ALSO HAD TO ANSWER TO PARLIAMENTS. THE MEETING, HE SAID, WILL BE LOW-KEY AND HELD AT THE MFA SECRETARIES-GENERAL OR DIRECTORS LEVEL; NO COMMUNIQUE OR PUBLIC STATEMENT IS PLANNED.

4. THE DUTCH MISOFF SAID THE NETHERLANDS HAD ENCOUNTERED SOME OPPOSITION WHEN IT DECIDED TO CALL FOR A MEETING LIMITED TO EUROPEAN CONTRIBUTORS. ORIGINALLY, IT HAD PLANNED TO RESTRICT THE SESSION TO EUROPEAN CONTRIBUTORS OF A BATTALION (IRELAND, FRANCE, NORWAY, FINLAND AND THE NETHERLANDS), BUT IT WAS PREVAILED UPON TO WIDEN PARTICI-PATION TO INCLUDE ITALY AND SWEDEN, WHICH CONTRIBUTE LOGISTICAL UNITS TO UNIFIL. (COMMENT: FRENCH UN MISOFF TOLD US FRANCE OBJECTS TO A UNIFIL CONTRIBUTORS' MEETING WHICH EXCLUDES NON-EUROPEAN PARTICIPANTS AND MAY NOT ATTEND THE HAGUE MEETING. END COMMENT). DUTCH MISOFF ADDED THERE WAS SOME GRUMBLING IN NEW YORK -- EVEN AMONG MEMBERS OF THE DUTCH MISSION -- ABOUT THE IDEA OF A MEETING IN THE HAGUE; SOME OF THE UNIFIL CONTRIBUTORS THOUGHT SUCH A MEETING WOULD BE HELD MORE PRODUCTIVELY AND DISCREETLY IN NEW YORK, WHERE PERM REPS FROM THE TROOP CONTRIBUTING MEMBER STATES ARE WELL-INFORMED AND REGULARLY CONSULT TOGETHER AND WITH THE UN SECRETARIAT ON UNIFIL ISSUES. DUTCH MISOFF SAID HE KNEW OF NO PRESSURE ON THE EUROPEAN CONTRIBUTORS TO WITHDRAW FROM UNIFIL IN JULY WERE THE PRESENT MANDATE TO BE EXTENDED. ON THE CONTRARY. HE SAID, NORWAY AND IRELAND -- WHICH IN THE PAST HAVE EXPRESSED RESERVATIONS ABOUT UNIFIL'S CONTINUED UNCERTAIN ROLE -- APPEAR PREPARED TO CARRY ON AFTER JULY, AND SWEDEN, WHICH CURRENTLY CONTRIBUTES A MEDICAL UNIT, HAS EXPRESSED WILLINGNESS TO OFFER A BATTALION. FRANCE, HE SAID. APPEARS TO HAVE LOST INTEREST IN UNIFIL AND IS CONCENTRA-TING ON THE MNF, BUT HE KNOWS OF NO FRENCH INTENTION TO PULL OUT OF UNIFIL. DUTCH MISOFF ASKED ABOUT CURRENT US IDEAS ABOUT THE FUTURE OF UNIFIL IN CONTEXT OF CNGOING LEBANON NEGOTIAT-IONS. US MISOFF REPLIED THAT THE NEGOTIATORS HAVE NOT YET RESOLVED THE POSSIBLE ROLE OF UNIFIL IN FUTURE LEBANESE PEACEKEEPING ARRANGEMENTS. THE IDEA WAS ON THE TABLE THAT UNIFIL MIGHT ASSUME A LIMITED SECURITY ROLE WITH THE LAF AT THE PALESTINIAN CAMPS AT TYRE AND SIDON AND PERHAPS ELSEWHERE IN LEBANON, FOLLOWING ISRAELI, SYRIAN AND FLO WITHDRAWAL. IN ANY EVENT, THE NEGOTIATORS HOPE TO WRAP-UP A WITHDRAWAL/SECURITY AGREEMENT WELL BEFORE THE PRESENT UNIFIL MANDATE EXPIRES. DUTCH MISOFF REMARKED THAT A FUTURE UNIFIL ROLE PROVIDING SECURITY AT THE REFUGEE CAMPS WOULD REQUIRE A CHANGE IN MANDATE AND WOULD RISK INVOLVING THE TROOP CONTRIBUTORS IN INTRA-ARAB CONFLICTS. SUCH A PROJECTED ROLE FOR UNIFIL WOULD

- LAST DECEMBER DEPARTMENT SENT FOLLOWING INSTRUCTIONS REGARDING DISPOSITION OF PLO VEHICLES TO EMBASSY NICOSIA (REF A). BEGIN TEXT: PATIENCE OF GOC AND EMBASSY NICOSIA IS MUCH APPRECIATED.



2. AFTER THE TRAGIC BOMBING OF THE EMBASSY SUMMARY. IN BEIRUT, ALL PARTIES AGREED IN THE APRIL 19 PLENARY IT WAS MORE IMPORTANT THAN EVER TO REACH AN EARLY AGREEMENT. CONSIDERABLE PROGRESS WAS MADE IN THE CIVILIAN COMMITTEE IN CLEANING UP MOST DIFFERENCES IN THE FIRST EIGHT ARTICLES OF THE AGREEMENT. INCLUDING THE AGREED MINUTES INTERPRETING THESE ARTICLES, THOUGH MUTUAL "RECOGNITION" AND GUIDANCE CONCERNING THE ECONOMIC BOYCOTT REMAIN OUTSTANDING. ^{7.} WE ALSO REACHED A CONSENSUS — SPELLED OUT BY DRAPER — OF HOW TO HANDLE THE CONTINGENCY OF A FAILURE BY PLO OR SYRIA TO PROCEED WITH WITHDRAWALS SIMULTANEOUSLY WITH THE IDF. 2. SUMMARY: INITIAL AND MOST PRODUCITVE TOPIC DISCUSSED DURING MILITARY WORKING ROUP'S APRIL 19 SESSION IN NETANYA WAS DEFINITION OF THE NORTHERN BOUNDARY OF THE SECURITY REGION. GEN HAMDAN PRESENTED A LEBANESE PROPOSAL WHICH WOULD ESABLISH THE NORTHERN BOUNDARY BEGINNING AT THE COST APPROX 40 KILOMETERS FROM METULLA AND MOVING EAST ROUGHLY ALONG THE AWWALI RIVER TO THE MOUNTAINS, THEN CONTINUING NORTHWARD, SKIRTING THE SLOPES OF THE MOUNTAIN RANGE, INCLUDING THE KAFRIYAH PASS, AND CONTINUING EAST ACROSS THE BIRA' TO THE LEBANESE-SYRIAN BORDER. HAMDAN'S PROPOSAL WAS ROUGHLY EQUIVALENT TO THE ISRAELI POSITION WITH THE EXCEPTION OF A 20 SQUARE KILOMETER AREA IN THE VICINITY OF THE PASS. GEN COOLEY SUPPORTED THE LEBAESE POSITION AND SUGGESTED THAT LEBANON AGREE NOT TO FORITY THE 20 SQUARE KILOMETER AREA. EINAN WAS RECEPTIVE TO THIS SUGGESTION AND AGREED TO PROPOSE ACCEPTANCE OF HAMDAN'S PROPOSAL TO HIS AUTHORITIES PROVIDED THE MINUTES OR A SIDE LETTER BE WRITTEN TO INDICATE LEBANNON'S COMMITMENT TO SECURRE THE AREA AROUND THIS NON-FORTIFIED AREA. AND TO SPECIFY AT THE AREA WOULD BE FREE OF ANY ELECTRONIC WARFARE EQUIPMENT. LONG RANGE ARTILLERY AND AIR DEFENSE MISSILES. EINAN AGREED AD REF-ERENDUM TO THE DRAFT ARTICLE OF THE SECURITY ANNEX DEALING WITH INTEGRATION OF HADDAD'S FORCES INTO THE LEBANESE ARMY TERRITORIAL BRIGADE. THE ISRAELI DEL ALSO INDICATED THAT ISREAEL WOULD ACCEPT

RAISING THE MAXIMUM ALTITUDE FOR AIR DEPENSE MISSILES OUTSIDE OF THE SECURITY REGION FROM 10,000 FEET TO 15,000 FEET ABOVE GROUND. EINAN QUALIFIED ISRAELI ACCEPTANCE OF THE DRAFT ARTICE ON NAVAL ACITIVITY IN LEBANON'S TERRITORIAL WATERS FALLING WITIN THE SECURITY REGION ON MUTUAL ACCEPTANCE OF MINUTES RELATED TO THIS ARTICLE; HOWEVER, NO AGREEMENT WAS REACHED ON ISREAL'S PROPOSED MINUTES, WHICH WOULD RESTRICT LEBANCE NAVAL ACTIVITY OUT OF THE SECURITY REGION. THE US DEL STRONGLY OPPOSED ANY SUCH RESTRICTIONS IN WATERS OUT OF THE SECURITY REGION. COOLEY ADDRESSED THE QUESTION OF US PARTCIPATION IN THE MIL COMMITTEE, PRPOSING THAT DIFFERENCES BE BRIDGED BY A FORUMLA THAT WOULD ALLOW FOR EITHER SIDE TO REQUEST THIS PARTICPATION ON A CASE-BY-CASE BASIS. FINAN STRONGLY OPPOSED SUCH A FORMULATION UNLESS BOTH SIDES AGREED TO INVITE US PARTICIPATION. END SUMMARY

3. APRIL 19 SESSION OF MILITARY WORKING ROUP IN NETANYA BEGAN BY DISCUSSION OF THE NORTHERN LIMIT OF THE SECURITY REGION. INITIAL POINTS VOICED BY GEN EINAN AND GEN HAMDAN WERE DIVERGENT

ON THE QUESTION OF WHETHER JABAL BARUK SHOULD BE INCLUDED IN THE SECURITY REGION OR NOT. HAMDAN SAID THAT IT COULD NOT BE INCLUDED, STRESSING THAT BARUK WAS SYMBOLIC FOR THE LEBANESE AND THAT ITS EXCLUSION FROM THE SECURITY REGION WAS PROBABLY EQUALLY SIGNIFICANT FOR THE SYRIANS. EINAN THEN EXPLAINED THE PSYCHOLOGICAL IMPORTANCE TO ISREAL OF HAVING A SECURITY REGION OF 40 KILOMETERS (MEASURED FROM METULLA) OR MORE. HAMDAN THEN TAPLED A PROPOSED NORTHERN BOUNDARY WHICH WOULD BEGIN AT THE COAST APPROX 40 KILOMETERS FROM METUALA, MOVE EAST ROUGHLY ALONG THE AWWALI RIVER TO THE MOUNTAINS, THEN CONTINUE NORTHWARD SKIRTING THE SLOPES OF THE MOUNTAIN RANGE INCLUDING THE KAFRIYAH PASS AND CONTINUING EAST ACROSS THE BIGA TO THE LEBANESE-SYRIAN BORDER. HAMDAN COTNSTRASTED THE LEBANESE AND ISRAELI PROPOSALS AND INDICATED THAT THE ONLY SIGNIFICANT DIFFERENCE WAS AN AREA OF APPROX 20 SQ KILOMETERS. AFTER EINAN RECOMMENDED THAT WE MOVE TO ANOTHER SUBJECT, GEN COOLEY INTERCEDED FOR THE LEBANESE, SAYING THAT HAMDAN'S PROPOSAL WAS REASONABLE CONSIDERING THAT:

- -- THE LAF WOULD SECURE THE AREAS NORTH OF THE LINE WHEREEVER IT MIGHT BE DRAWN.
- -- INFILTRATION ROUTES OF CONCERN CROSS THE KAFRIYAH PASS, THUS, IT IS MILITARILY MORE SIGNIFICANT THAN THE PEAK OF JABAL BARUK.
- -- INTELLIGENCE EXCANGE AND VERIFICATION MEASSURES WILL COVER THIS AREA.

COOLEY SUGGESTED THAT THE 20 SQ KILOMETER AREA NOT BE FORTIFIED. EINAN WAS RECEPTIVE TO THIS SUGGESTION AND AGREED TO PROPOSE

MESSAGE / ANNOTATION:

ACCEPTANCE OF HAMDAN'S PROPOSAL TO HIS AUTHORITIES PROVIDED AGREED MINUTES OR A SIDE-LETTER BE WRITTEN INDICATING LEBANON'S COMMITMENT TO CONTROL ACCESS AND SECURE THE AREA AROUND THIS NON-FORTIFIED SECOR AND SPECIFYING THAT THE AREA WOULD BE FREE OF LONG-RANGE ARTILLERY, RADARS, AIR DEF MISSILES AND ELECTRONIC WARFARE EQUIP TO INCLUDE SIGINT AND ELINT EQUIP. HAMDAN SAID SUCH AN AGREEMENT COULD BE READCHED AND IT WAS AGREED AD REFERENDUM THAT AIR TRAFFIC CONTROL RADARS WOULD BE PERMITTED.

- 4. EINAN AND HAMDAN AGREED AD REFERENDUM TO DRAFT ART OF THE SECURITY ANNEX DEALING WITH THE INTEGRATION OF HADDAD'S FORCES AINTO THE LEBANESE ARMY TERRITORIAL BRIGADE.
- 5. EINAN SAID THAT ISRAEL WOULD ACCEPT RAISING THE MAXIMUM ALTITUDE FOR AIR DEF MISSILES OUTSIDE OF THE SECURITY REGION FROM 10,000 TO 15,000 FEET ABOVE GROUND AS REQUESTED BY LEBANON.
- 6. EINAN QUALIFIED ISRAELI ACCEPTANCE OF COL RUHAYYIM'S DRAFT ART ON AUTHORIZED LEBANESE NAVAL ACTIVITY IN THE TERRITORIAL WATERS FALLING WITHIN THE SECURITY REGION ON THE WRITING OF MUTUALLY ACCEPTABLE MINUTES SPECIFYING PROCEDURES ON THE EXCHANGE OF INFO ON SUSPECTED VESSELS AND FOR CONTINUOUS COMMUNICATIONS BETWEEN LEBANESE AND ISRAELI NAVAL ELEMENTS. EINAN ALSO LINKED ACCEPTANCE OF THE PROVISIONS APPLYING WITHIN THE WATERS OF THE SECURITY REGION TO ISRAELI DEMANDS FOR RE-STRICTIONS IN LEBANESE TERRITORIAL WATERS OUTSIDE THE SECURITY REGION. COOLEY CLEARLY STATED THE US COULD ACCEPT NO RESTRICTIONS ON LEBANESE SOVEREIGNTY OVER ITS TERRITORIAL WATERS OUTISE THE SECURITY REGION. (COMMENT. EINAN'S MENTION OF TERRITORIAL WATERS WITHIN THE SECURITY REGION IMPLIES DE FACTO ISRAELI AGREEMENT THATTHE SECURITY REGION EXTENDS INTO LEBANON'S TERRITORIAL WATERS ALONG THE COAST. END COMMENT) 7. IN AN EFFORT TO BRIDGE THE CURRENT ISREALI AND LEBANESE POSITIONS ON US PARTICIPATION IN THE SECURITY ARRANGEMENTS COMMITTEE, COOLEY PROPOSED THAT EITHER SIDE COULD REQUEST US PARTICIPATION ON THE COMMITTEE ON A CASE-BY-CASE BASIS. HAMDAN SAID LEBANON WOULD CONSIDER THIS IDEA FAVORABLY, BUT EINAN WAS STRONGLY OPPOSED TO US REP UNLESS BOTH SIDES AGREED TO INVITE THE US TO PARTICIPATE. COOLEY STATED THAT THE US WOULD PREFER TO LIMIT ITS PARTICIPATION AND THAT THE US COULD REFUSE REQUESTS TO PARTICIPATE. EINAN ADDED THAT ISREAL DOES NOT WANT US INVOLVMENT IN EVERY ISSUE, BUT THAT BEFORE ANY UNRESOLVED PROBLEM WAS REFERRED TO THE JOINT LIAISON COMMITTEE, BOTH PARTIES WOULD INVITE US PARTICIPATION IN THE SECURITY ARRANGEMENTS COMMITTEE.
