FOR MY VERY INTENSIVE MEETINGS WITH THE LEADERSHIP OF THE
ARGENTINE GOVERNMENT. OTHERS HAVE BEEN DEVELOPED HERE.
IN THESE MORE THAN THREE DAYS OF VERY DETAILED TALKS
THERE HAS BEEN A FURTHER IDENTIFICATION AND REFINEMENT
